



Target Market Determination – Funds Management

This Target Market Determination (TMD) is required under section 994B of the *Corporations Act 2001* (Cth) (**the Act**). It sets out the class of consumers for whom the product, including its key attributes, would likely be consistent with their likely objectives, financial situation and needs. In addition, the TMD outlines the triggers to review the target market and certain other information. It forms part of One Management Investment Funds Limited's design and distribution arrangements for the product.

This document is **not** a product disclosure statement and is **not** a summary of the product features or terms of the product. This document does not take into account any person's individual objectives, financial situation or needs. Persons interested in acquiring this product should carefully read the Product Disclosure Statement (**PDS**) for Landen Funds ARSN 653 001 015 and the Supplementary Product Disclosure Statement the Specific Investment Fund – Norwest (**SPDS**) before making a decision whether to invest in Landen Funds.

Target Market Summary

This product is likely to be appropriate for a consumer seeking to diversify their investment portfolio to include exposure to secured loans with a higher rate of return commensurate with the risk exposure. The Class will be exposed to loans that are secured against the borrower's assets which may eventually include Australian real property. Consumers in the target market have a medium investment timeframe, high risk appetite and limited needs for access to capital. The product intends to pay a regular monthly income.

Investment products and diversification

For example, a consumer may seek to construct a conservative portfolio with a satellite/small allocation to growth assets. In this case, it may be likely that a product with a *High* or *Very High* risk/return profile is consistent with the consumer's objectives for that allocation notwithstanding that the risk/return profile of the consumer as a whole is *Low* or *Medium*.
